The successful candidate will focus almost exclusively on inpatient care—providing timely, evidence-based management of complex endocrine and metabolic disorders in a quaternary-referral academic center—while contributing to our mission of education, scholarship, and service.

Major Clinical Responsibilities

- Serve as **attending physician** on the inpatient endocrinology and diabetes consult services at UCSD Medical Center (Hillcrest) and Jacobs Medical Center (La Jolla), typically 26–30 service weeks per year.
